Luther advises Performance Media on the merger of four online marketing agencies

Hamburg – Four leading German online marketing firms merged in March to form the Performance Interactive Marketing Alliance (PIMA), with the involvement of private equity firm Equistone Partners Europe. The shareholders of Performance Media received advice from law firm Luther Rechtsanwaltsgesellschaft mbH during the merger.

In the future, the four companies – Performance Media, econda, Blue Summit Media and DELASOCIAL – will operate under a single holding company, the Performance Interactive Marketing Alliance (PIMA). The goal is to expand their market leadership in the field of automated online marketing and offer customers services from a single source – including services related to digital media planning, high-end Web analyses for e-commerce customers, SEO campaigns, and communication services. The merger is still subject to approval by the cartel authorities.

The merger took place with the involvement of the funds advised by Equistone Partners Europe (EPE). EPE's goal in this transaction is to support the group's organic and inorganic growth. In the medium term, plans call for further companies from the field of marketing automation to join the holding company.

The Performance Interactive Marketing Alliance (PIMA), headquartered in Hamburg, will bring together 360 employees at locations in Hamburg, Munich, Berlin, Düsseldorf and Karlsruhe as well as the development site in Belgrade under a single roof. The newly established holding company serves more than 900 customers in all, including companies such as Lufthansa, Swarovski and

Montblanc. The full group's consolidated sales to outside parties amounted to about 140 million euros in 2013. With 100 million euros in sales in 2013, Performance Media is the largest of the four online marketing firms involved.
