The transaction comprises all assets and contractual relationships relating to the distribution and production of Laurens Spethmann Holding's sweetener and instant tea business, including the trademark rights to the well-known "HUXOL" brand. The production unit is located at the Medin plants in Faulbach. All shares in MEDIN GmbH & Co. KG and Nutrisun GmbH & Co. KG will remain with LSH. Likewise, the employees of MEDIN and Nutrisun will not transfer to the KRÜGER GROUP. The implementation phase will begin in the next few weeks and is expected to extend into the third quarter of 2023.
