Green Deal: Luther advises family business Holger Grelck Forstbaumschulen on partnership with Beyond Capital Partners

Berlin, 04.10.2023 – Holger Grelck Forstbaumschulen GmbH has entered into a partnership with the private equity investor Beyond Capital Partners. As one of the leading German forest tree nurseries, the company makes an important contribution to the reforestation of forests and thus to achieving Germany's climate protection goals. In the transaction, the family-run Holger Grelck Forstbaumschulen GmbH and its owners received comprehensive legal and tax advice from Luther Rechtsanwaltsgesellschaft.
