Future strategy: Luther implements measures for the digitalisation of school processes for the NRW Ministry of Education

Dusseldorf, 21.02.2024 – As part of the implementation of teaching and learning in the digital world, the Ministry of Schools and Education NRW has commissioned the development and introduction of Moodle courses to support digitally-supported teaching and learning processes and has successfully completed the state-wide introduction of these courses. The project was supported by Luther Rechtsanwaltsgesellschaft in terms of procurement, contract and IT law.

The future-orientated work with digital teaching materials at schools in North Rhine-Westphalia has been given further impetus.
