# Luther advises US sports giant Wasserman on cooperation with Sauerland boxing stable

Stuttgart – The boxing stable founded by the legendary promoter Wilfried Sauerland and the US sports giant Wasserman will be extensively cooperating in the future. Wasserman has taken over all business activities of the Sauerland Group. The aim is to become the world's leading boxing company. In addition to the Sauerland companies operating in Germany, the business activities in Switzerland and England are also included in the transaction.
