## Dutch VebeGo takes over: Luther advises Vorwerk on sale of hectas group

**Essen - Luther Rechtsanwaltsgesellschaft advised the Vorwerk group on the sale of the hectas group to the facility management company VebeGo. Several companies in Germany, the Netherlands and Austria will be transferred to the Dutch family-owned company.**

The hectas Group from Wuppertal, founded in 1974, will be transferred from the Vorwerk family of owners to the Dutch VebeGo on 1 January 2022, subject to approval by the Cartel Office.

With the acquisition of the hectas Group, VebeGo plans to strengthen its market value in Germany, the Netherlands and Austria. The more than 8,000 affected employees of the hectas group as well as existing contracts and agreements are to be taken over. Vorwerk, in turn, plans to concentrate on the direct sales concept of its products in the future.
