The Revised IBA Rules on the Taking of Evidence: New Perspectives and Remaining Challenges

In December 2020 the IBA adopted – and last month formally released – its 2020 Rules on the Taking of Evidence in International Arbitration. It is only the second revision since first published in 1999 and updates the rules, inter alia, to take into account today's widespread use of remote or hybrid hearings and includes a provision on illegally obtained evidence.
