After having discussed the possibility of the adjustment of prices in order to address raising costs due to inflation, raising costs of production, shortages and bottlenecks during our last unyer commercial webinar, our commercial and trade law experts will now discuss further current topics that challenge supply chains.

The focus of this webinar will be on (i) the progressively stricter international compliance rules regarding the level of care along supply chains (e.g., the European Union's Directive on corporate sustainability due diligence, the German *Lieferkettensorgfaltspflichtengesetz* (LkSG) or the French law on the duty of care of parent companies (Law no. 2017-399), (ii) current shifts in distribution systems and (iii) new pitfalls overriding mandatory laws governing distribution agreements (e.g., the new French law to strengthen the balance in commercial relations (EGalim 3).

To dissect all these topics, unyer is hosting its commercial webinar on 20 June 2023. This session will help you to recognize possible, direct and indirect, impacts of supply chain regulation on your business and identify the first steps to address any challenges.
