# A. Visa regulations

Ordinary passport holders from Brunei Darussalam, Cambodia, Indonesia, Laos, Philippines and Thailand are given visa exemption for 14 days. Ordinary passport holders from Singapore, Russia and Vietnam are given visa exemption for 30 days.

Apart from the above, any foreigner wishing to enter Myanmar must obtain a valid visa and hold a passport with six months' validity from the date of entry into Myanmar.

## I. Visa categories

Foreigners may choose between fourteen different types of visas:

- Business visa;
- Crew visa;
- Education visa;\*
- Employment visa;\*
- Entry visa for diplomatic guests ;
- Entry visa for non-diplomatic staff and their immediate family members;
- Gratis diplomatic/official courtesy visa (GDC/GOC);
- International organisations visa;
- Journalist visa;\*
- Religious visa;
- Social visa;
- Tourist visa;
- Transit visa;\* and
- Workshop/seminar/meeting/research visa.\*

**Political Update:** \* Certain types of visas may currently not be available.

**Comment Luther:** In theory, a foreigner may apply for an employment visa. Based on our experience, any application for an employment visa shall be supported by an invitation letter or appointment letter from the employer, as well as the applicant's labour card from the Ministry of Labour. Due to the restrictive issuance of labour cards to foreigners, most people working in Myanmar do not apply for an employment visa, but simply hold a business visa.

## II. Multiple journey visas

The following types of visas may be issued for multiple journeys to Myanmar:

- Business visa;
- Crew visa;
- Diplomatic/official courtesy visa (GDC/GOC);
- Education visa;
- Entry visa for diplomatic guests visa;
- Entry visa for non-diplomatic staff and their immediate family members visa;
- International organisations visa;
- Religious visa; and
- Social visa.

**Political Update:** Only Business visas, social visas and crew visas are currently available for multiple journeys.

**Comment Luther:** Some visas allow foreigners to stay in Myanmar for the full term of the visa (i.e. up to 12 months). It should be noted, however, that such visas will not relieve foreigners from the requirement of applying for a Foreigner Registration Certificate, should they intend to stay in Myanmar for 90 or more consecutive days.

## III. Application process

Please find below an overview of the options to apply for a Myanmar visa:

### 1. Myanmar embassies/consulates

In general, a visa may be applied for at one of Myanmar's 40 foreign embassies and consulates, which will issue either a single-entry or multiple-entry visa.

The application process and even the required documents may vary depending on the relevant embassy/consulate.

**Comment Luther:** Most Myanmar authorities will require the prior issuance of single-entry or a number of short-term multiple-entry visas, before granting a one year multiple-entry visa.

## 2. E-Visa

Citizens of ca. 100 countries may apply for electronic business or tourist visas online (<https://evisa.moip.gov.mm/>). E-Visas are usually valid for 90 days from the date of issue, allowing a stay of up to 28 days (for tourists) or 70 days (for business travelers with an invitation from an enterprise registered in Myanmar).

The following documents shall be submitted online:

- Official application form;
- Letter of invitation from the sponsoring enterprise;
- Request letter from the sponsoring enterprise;
- Undertaking of responsibility signed by all directors of the sponsoring enterprise confirming responsibility for the foreigner's conduct in Myanmar, including compliance with the visa terms and Myanmar laws, as well as prohibition of external employment;
- Corporate documents of sponsoring enterprise (e.g. Certificate of Incorporation and Company Extract); and
- One recent colored passport photo (2"x1.5").

The fee for a business e-visa is USD 70, while a tourist e-visa costs USD 50. E-visas are issued free of charge to children under seven years of age.

The holder of an e-visa must enter Myanmar via one of the following ports of entry:

- Yangon International Airport;
- Nay Pyi Taw International Airport; or
- Mandalay International Airport;

E-stay extension is available. This allows foreigners residing and working in Myanmar who have entered Myanmar via e-Visa (Business) to apply for a Stay Extension and Re-entry Visa online.

**Political Update:** Do note that Business e-Visa application can currently take up to 3 weeks or longer.

## 3. Visa on arrival

Citizens of China, Hong Kong, India, Japan, Macao and the Republic of Korea arriving and entering at Yangon International Airport, Mandalay International Airport or Nay Pyi Taw International Airport may apply for tourist visas on arrival.

## 4. Department of immigration (within Myanmar)

Foreigners already in Myanmar may also apply with the Department of Immigration and National Registration of the Ministry of Immigration and Population ("Ministry of Immigration") for a new visa (please see below).

## IV. Overstay fine

Unapproved overstay will result in a fine (currently USD 3 per day for the first 90 days of overstay; USD 5 per every subsequent day of overstay), to be paid before leaving Myanmar, either to the relevant authorities or at one of Myanmar's international airports.

**Comment Luther:** *Foreigners staying in Myanmar for 90 consecutive days or more must apply for a Foreigner Registration Certificate. In case of non-compliance, the authorities may not allow the foreigner to leave the country.*

## B. Foreigners residing and working in Myanmar

### I. Overview

Any enterprise engaging foreigners to work in Myanmar must ensure that they hold proper immigration documents. As Myanmar did not yet establish a comprehensive system of work passes/permits, most foreign employees currently hold a business visa only.

By law, foreigners residing in Myanmar for more than 90 days are further required to apply for a Foreigner Registration Certificate ("FRC").

**Comment Luther:** *It should be noted, that foreigners holding a business visa are not allowed to provide services as independent consultants without registering a business presence in Myanmar.*

### II. Application process within Myanmar

According to the latest visa regulations (please see below), visa and Long-Term Stay Permit applications within Myanmar, as well as their renewal, must be submitted at least 60 days before expiry of the foreigner's current stay permit or visa.

**Comment Luther:** *Initially, the Myanmar immigration authorities usually issue documents valid for three to six months only. From the second application, business visa and Long-Term Stay Permits may be issued with one year duration. Do note that the internal policies of the Department of Immigration change regularly, and the duration of business visa and Long-Term Stay Permits may be limited to three to six months, depending on the employer. Please note, that the original passport is required for the collection of the visa and Long-Term Stay Permit.*

Depending on the type of applicant, different authorities shall be responsible for the application process, such as the Directorate of Investment and Company Administration ("DICA"), the Myanmar Investment Commission, the Ministry of Education (for foreign teachers), respective line ministries (for INGOs) or the Central Bank of Myanmar (for foreign bank employees).

#### 1. Visa

To apply for a visa within Myanmar, employees of DICA registered companies shall submit the following documents/information to DICA:

- Company Extract;
- Current business activities of the company (including copies of any permits or licenses issued to the company by relevant government agencies or organizations, as well as business contracts showing the employer's business activities in Myanmar);
- Statement confirming the existence and use of the office address registered with DICA, stamped and signed by a director of the company;
- Undertaking signed by all directors of the company confirming responsibility for the foreigner's conduct in Myanmar, including avoidance of political activities and contact with terrorist organizations, non-engagement in financial fraud and criminal offence, compliance with Myanmar's laws as well as compliance with the visa terms and prohibition of external employment, stamped and signed by any director of the company;
- Copies of tax returns (especially the evidence of annual return filing), audited financial statements of the current and previous two fiscal years and other evidence of corporate income tax filings and payments;
- Personal Income Tax payment receipt of applicant;
- Completed CV in the format issued by DICA;
- Job description and the foreign employee's duties within the company;
- Professional qualification certificates of the foreigner and copy of employment contract;
- List of local and foreign employees of the company, including full names, nationalities, passport numbers and phone numbers;
- Copy of the passport, visa sticker, stay permit sticker and current immigration stamp of the applicant. The first page of the passport (showing the applicant's particulars) must be stamped and signed by a director of the company;
- Form C;
- Marriage certificate of the applicant (only if the spouse applies as dependent);
- Birth certificates of the children of the applicant (only if the children apply as dependents); and
- Two colored passport photos (2"x1.5").

On 14 September 2022, DICA announced the following new regulations for the issuance of recommendation letters for visa and stay permit applications and extensions:

- To be eligible to apply for a recommendation letter, the employing enterprise must have been incorporated/registered with DICA for at least one year before submitting a visa extension application;
- Enterprises which have in the past been “suspended” for failure to file an Annual Return, or have been struck off the register, will only be allowed to apply for stay permit and visa extensions after they have complied with their legal obligations for a period of at least one year following the suspension/ strike off; and
- Enterprises must apply for the recommendation letter at least 90 to 120 days before expiry of the foreigner’s current permit or visa.

On 1 November 2022, DICA amended its previous announcement and clarified that applications shall be submitted **at least 60 days before the current visa’s expiry**.

## 2. Long-term stay permit

For the application of a long-term stay permit within Myanmar, the following documents shall be submitted to the Department of Immigration and National Registration:

- Cover letter;
- Authorization letter;
- Official application form;
- Corporate documents of sponsoring enterprise (e.g. Certificate of Incorporation and Company Extract);
- Copy of Form C;
- Approval letter number from the relevant Ministry (e.g. Ministry of Investment and Foreign Economic Relations);
- Approval letter from the Nay Pyi Taw Immigration;
- Copy of FRC (if any); and
- Two recent colour passport photos (2”x1.5”).

## 3. Foreigner Registration Certificate

For the application of an FRC within Myanmar, the following documents shall be submitted to the Department of Immigration and National Registration:

- Cover letter
- Official application form;
- Copy of Form C;
- Approval letter from the Nay Pyi Taw Immigration Department; and
- Five recent colour passport photos (2”x1.5”).

## 4. Guest residence report

According to the Registration of Foreigners Rules (1948), foreign employees holding a long-term stay permit and FRC shall file a guest residence report with the relevant Township Immigration Department.

**Comment Luther:** *Strictly speaking, such Guest Residence Report must be updated weekly. In practice, this is however seldom done anymore.*

## III. Form C (Occupation of residential premises)

Since October 2016, foreigners occupying residential premises, shall, within 24 hours after arrival, be reported by the landlord to the relevant Ward Administration Office and Township Office of the Ministry of Immigration (using a copy of the hotel arrival report/Form C).

**Comment Luther:** *Neither the Registration of Foreigners Act (1940) nor the Registration of Foreigners Rules (1948) contain any provisions on the occupation of residential premises by foreigners. The terms and conditions for business visas as published by the Ministry of Immigration and Population do, however, provide, that foreigners may stay at hotels, motels and guest houses holding legal licenses issued by Myanmar Government, and factories and workshops legally permitted as well as human dwellings.*

*Upon enquiry, various immigration offices verbally confirmed that holders of a business visa are eligible to occupy residential premises. According to the immigration offices, the premises should, however, be rented by a company registered in Myanmar, and may then be offered to the foreigner employed by such company.*

## C. MIC companies

### I. Overview

Companies registered with the Myanmar Investment Commission under the Myanmar Investment Law (2016) are already subject to stricter scrutiny and shall apply for labour cards for foreigners holding the following positions:

- Senior management;
- Technical experts; and
- Consultants.

**Comment Luther:** Limited information is available on definitions of “senior managers”, “technical experts” and “consultants”. Further, the Myanmar Investment Commission did not specify whether this requirement shall apply only to long-term appointments, or even to short-term engagements.

*In practice, most companies registered with the Myanmar Investment Commission apply for a labour card for each and every foreign employee staying in Myanmar on a long-term basis and report them in their Quarterly Performance Reports.*

### II. Application process

Currently, the application process consists of two main steps:

- Application with the Myanmar Investment Commission; and
- Application with the Department of Labour and Department of Immigration of the Ministry of Immigration.

#### 1. Myanmar Investment Commission

##### Supervision Committee

With effect from 30 June 2024, applications for the employment of foreign experts, increases in the number of foreign employees, and the resignation of foreign employees must be submitted online.

In case of a new employee, the following documents/information shall be submitted via the Myanmar Investment Online (MyInO) account to the Supervision Committee of the Myanmar Investment Commission:

- Form BO16 (Application for appointment of foreign experts);
- Corporate documents of the sponsoring enterprise (e.g. certificate of incorporation, company extract and MIC permit);
- Passport photo of the applicant;
- Undertaking letter for the applicant by the sponsoring enterprise;
- Updated quarterly report of the sponsoring enterprise;

- Copy of tax clearance certificate, advance income tax filing documents or tax assessment notice of the sponsoring enterprise;
- CV of the applicant;
- Passport, visa sticker, long-term stay permit sticker and current immigration stamp of the applicant;
- Employment contract of applicant;
- Notarial copy of the government-recognized education/professional qualification certificate(s) of the applicant; and
- Official payment receipt for Form BO16.

For the resignation / termination of a foreign employee, the following documents/information shall be submitted via the Myanmar Investment Online (MyInO) account to the Supervision Committee of the Myanmar Investment Commission:

- Form IR1 (Application for resignation of foreign employees)
- Appointment letter of Myanmar Investment Commission (MIC)
- Resignation letter; and
- Air ticket.

All documents and information shall be submitted to the Myanmar Investment Commission before, but in any case not later than seven working days after the date of arrival of the new foreign employee in Myanmar.

##### One-stop service centre

Since 30 September 2021, applications for stay permits/visas and work permits shall be submitted to the one-stop service centre of the Myanmar Investment Commission via online application. The applications shall include the following details:

- Applicant(s) name(s) and passport information;
- Approval letter of Supervision Committee of the Myanmar Investment Commission;
- Form C;
- Labour Card;
- Undertaking letter signed on behalf of the board of directors ensuring confirming that they the company acts as a “guarantor” for the foreigner while he/she is in Myanmar;
- Passport, visa sticker, long-term stay permit sticker and current immigration stamp of applicant;
- Marriage certificate of applicant with spouse (only in case of an application of a dependent); and
- Birth certificate of children of applicant (only in case of an application of a dependent).

## 2. Department of Immigration

Once the one-stop service centre of the Myanmar Investment Commission has approved the application, the following documents shall be submitted to the Department of Immigration for the visa and long-term stay permit of the applicant:

- Cover letter;
- Authorization letter;
- Official application form;
- Form FRC;
- Corporate documents of the sponsoring enterprise (e.g. certificate of incorporation, company extract and MIC permit);
- Approval letter of the one-stop service centre of the Myanmar Investment Commission;
- Marriage certificate of the applicant with spouse (only in case of an application of a dependent);
- Birth certificate of children of applicant (only in case of an application of a dependent);
- Copy of Form C; and
- Two recent colour passport photos (2"x1.5").

### Foreigner registration certificate

Once the Supervision Committee and one-stop service centre of the Myanmar Investment Commission have approved of the application, the following documents shall be submitted to the Department of Immigration for the FRC of the applicant:

- Cover letter;
- Official application form;
- Approval letter of one-stop service centre of the Myanmar Investment Commission; and
- Five recent colour passport photos (2"x1.5").

## 3. Department of Labour

Finally, the following documents shall be submitted to the Department of Labour for the labour card of the applicant:

- Cover letter;
- Authorization letter;
- Official application form;
- Corporate documents of the sponsoring enterprise (e.g. certificate of incorporation, company extract and MIC permit);
- Approval letter of the one-stop service centre of the Myanmar Investment Commission;
- CV of the applicant;
- Undertaking letter;
- Passport, visa sticker, long-term stay permit sticker and current immigration stamp of the applicant;
- Employment contract of the applicant;
- Copy of tax clearance certificate, advance income tax filing documents or tax assessment notice of the sponsoring enterprise; and
- Three recent colour passport photos (2"x1.5").

## III. Reporting obligations

Companies are required to notify the Myanmar Investment Commission of the foreigner's commencement of work, current employment status, change of residential address and phone number, transfer of duties, resignation and departure from Myanmar.

## D. Violations

### I. Visa violations

Violations of the visa terms, as well as entry into Myanmar with an incorrect visa (e.g., a business visa instead of an education visa), may be a criminal offense and result in legal action being taken:

- Non-compliance with visa terms may result in the blacklisting of the visa applicant, as well as the inviting company and its directors.
- A violation of visa terms (or use of an incorrect visa) may further result in penalties under the Burma Immigration (Emergency Provisions) Act (1947), ranging from fines to imprisonment for a term of six months up to five years.
- Any violation of the registration obligations (Form-C) may result in fines and/or imprisonment of up to one year pursuant to the Burma Immigration (Emergency Provisions) Act (1947).
- The forgery or falsification of supporting documents, or submission of falsified documents, may be punished under the Penal Code (1861) with a fine and/or imprisonment.
- Notably, the Ministry of Population and Immigration has clarified that violations of the Burma Immigration (Emergency Provisions) Act (1947) may result in prosecution of both the visa holder as well as the company or organization which has assisted in the visa application, e.g., if the visa holder is engaged in any form of paid or unpaid outside employment.

### II. Violations of other laws

Violations of visa terms may often coincide with violations of other laws, which will be prosecuted accordingly, such as:

- The Association Registration Law (2022) imposes a blanket prohibition on the participation and support of any organization which is not formally registered in Myanmar. Violations may result in fines and/or imprisonment.
- Non-payment of personal income tax in accordance with the Income Tax Law (1974) may result not only in administrative fines and interest pursuant to the Tax Administration Law (2019), but also in criminal prosecution for tax evasion, which is punishable with imprisonment for up to seven years. Notably, penalties for tax evasion can be levied on both the foreign employee, as well as the employer.
- Pursuant to Public Ruling 3/2022 dated 16 November 2022, any case of tax evasion may further constitute a violation of the Anti-Money Laundering Law (2014).




