- 1992: Krüger und Partner Rechtsanwalts-gesellschaft mbH was founded by partners from Arthur Andersen
  - 1995: The firm was reorganised to found one of the first law firms: Freihalter Krüger und Partner Rechtsanwalts-gesellschaft mbH
  - 1998: The firm's name was changed to Andersen Freihalter Rechtsanwalts-gesellschaft mbH
  - 2000: Merger with Luther & Partner in Hamburg and Berlin to become Andersen Luther Rechtsanwalts-gesellschaft mbH
  - 2002: Merger with Menold & Aulinger to become Luther Menold Rechtsanwalts-gesellschaft mbH and form an association with Ernst & Young
  - 2005: The firm's name was changed to Luther Rechtsanwalts-gesellschaft mbH
  - 2007: The association with Ernst & Young was discontinued
  - 2021: unyer (Swiss Verein) was founded by Luther Rechtsanwalts-gesellschaft mbH and Fidal
