Luther advises Wolf Group on sale of care facilities

Munich – The Wolf Group, a previously family-owned nursing home operator, was sold to Berliner Pflege-Holding cosiq GmbH. The sellers were advised on the transaction by Luther Rechtsanwaltsgesellschaft.

The Wolf-Pflege Group operates various senior citizens', nursing and therapy facilities in Hesse, Lower Saxony and Thuringia, in which approx. 270 residents are cared for both in senior citizens' nursing care and in neurological specialist and intensive care. For reasons of age, the owner couple Wolf, who have been active since the beginning of the 1990s, are withdrawing from the business founded in the 1960s in Eschwege in northern Hesse. The careful search for a successor led to the choice of Berlin-based cosiq GmbH. The company specialises in the development, restructuring and operation of integrative forms of care and living. Under its umbrella, the company combines the latest models for "living with service" with outpatient and inpatient care, specialist care and alternative forms of care.

A joint Luther team of experts from the fields of M & A and real estate law supported the Wolf family in the sale. "The transaction was particularly complex, as the share transfers had to be linked to several property purchase contracts to be processed simultaneously. There were around ten different parties involved, including the Hamburg-based INP Group," explains Dr. Christian Rodorff, Partner at Luther. "The healthcare sector is currently particularly interesting for investors because the regionally fragmented markets in Germany still offer consolidation potential and stable growth can be expected due to the ageing of the company."

At the request of the parties, the respective purchase prices were not disclosed.
