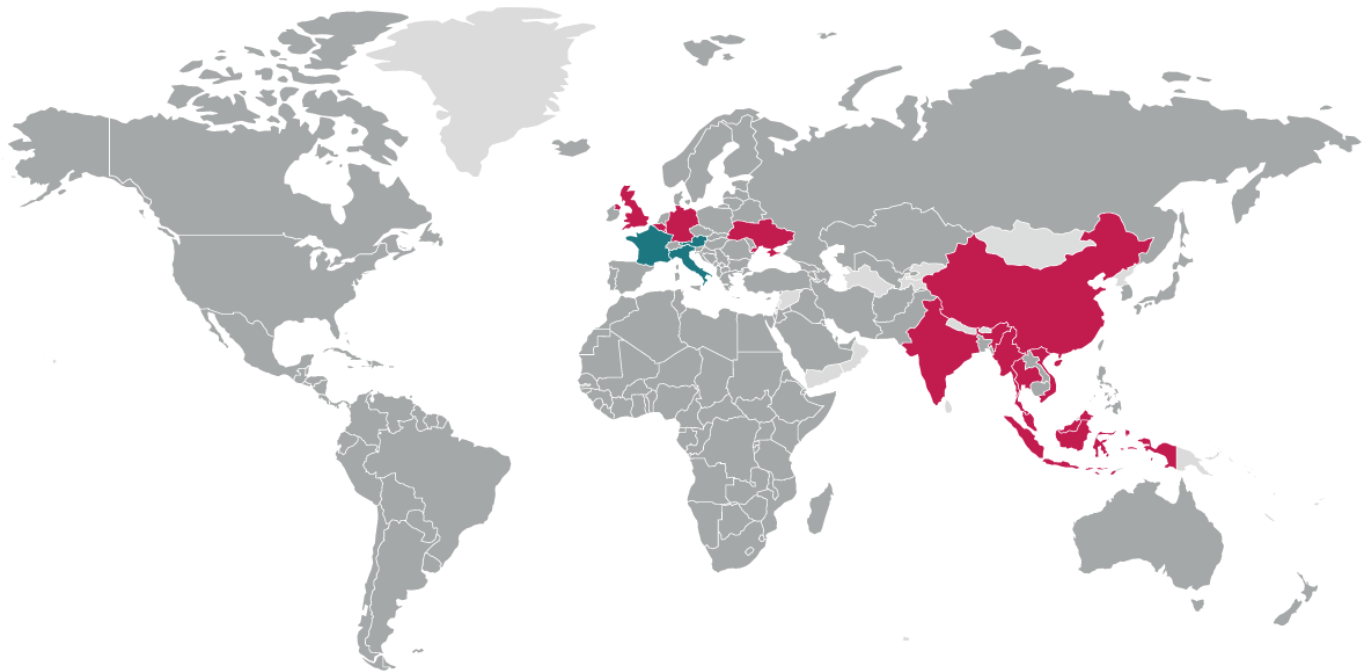

The Lawyer European Awards

Luther has been named “Law Firm of the Year: Germany 2024” by The Lawyer, one of the most well-known legal magazines worldwide.



JUVE

In its online publication of the JUVE Guide of Commercial Law Firms as of November 2025, a total of 55 Luther lawyers were recommended, eleven of whom were named ‘Leading Names’ and three ‘Rising Stars’. Two further colleagues were recommended in the JUVE Guide Tax 2025. Luther was ranked in 30 practice areas, three of which are in the highest category with 5 stars. In addition, Luther was one of four law firms nominated by JUVE for the ‘Law Firm of the Year 2025 for Dispute Resolution’ award. In 2019, Luther received the highest award from JUVE Publishing as ‘Law Firm of the Year 2019’.



Chambers

In 2026, Luther was recognised by Chambers Europe for 18 practice areas in Germany as well as in two practice areas in Luxembourg. In addition, 24 partners were included in the Individual Ranking. Moreover, in 2026, Luther was recognised by Chambers Global in five practice areas in Germany and in one each in Luxembourg and Myanmar, while nine partners were also included in the Individual Ranking.



The Legal 500

The Legal 500 Germany 2026 recommends Luther in 40 areas of law, with “Top Tier” rankings in two of these areas. 96 lawyers are being recommended, 18 of whom have been specially recognised as “Leading Individual” or “Next Generation Partner”. “The Legal 500 EMEA 2025” recommends Luther for seven areas of law in Luxembourg, and nine lawyers are also recommended, two of whom have been specially recognised as “Leading Individual”. “The Legal 500 Asia Pacific 2025” recommends Luther and two of its lawyers for one area of law in Myanmar.

Two Luther lawyers have been included in the recommendations for Germany in the Green Ambassadors Europe Guide 2025. This guide, published by Legal 500, recognises lawyers who are particularly committed to sustainability and the green transition - both in their client work and beyond.



Kanzleimonitor

Kanzleimonitor 2025/2026 recommends Luther in 20 areas of law. In addition, five Luther lawyers were listed in the individual recommendations, two of whom were even included in the top 100 lawyers.
