Luther consults Vorwerk for the acquisition of Norddeutsche Teppichfabrik

At the end of January 2014, the board of creditors has consented to the purchase agreement with the subsidiary of Vorwerk, TPH Teppich-Produktions- und Handels-GmbH: Effective immediately, Vorwerk Teppichwerke will take over operations of Norddeutsche Teppichfabrik. In particular, Vorwerk's strong integration in the trade and the sales strength of the group have convinced the creditors that an economically sensible continuation of operations is possible.

The Vorwerk concept envisages that production will continue in the location Geesthacht as well as in Hameln, with an adjusted number of employees and using synergy potential. The brand Nordpfeil will remain in the market next to the brand Vorwerk.

Luther has provided consultation in the structure of this transaction and in particular in the negotiations for the purchase agreement as well as in respect to labor and environmental law issues. Beyond this, Luther supported Vorwerk in the rental of industrial properties of the debtor in legal aspects.
