Luther advises Immofinanz Group in the acquisition of 18,000 residential units and the residential management of Prelios

Frankfurt am Main – Luther Rechtsanwaltsgesellschaft mbH advised the Austrian Immofinanz Group in two projects on legal and tax aspects: It supported the Immofinanz subsidiary BUWOG in the purchase of a portfolio of 18,000 residential units. Furthermore, it advised Immofinanz in the takeover of the residential management transaction of Prelios Deutschland GmbH.

Agreements were signed for the acquisition of 18,000 residential units for around EUR 900 million. The residential units are mostly located in Kiel, Lübeck, Hamburg, and Braunschweig. Currently, the portfolio belongs to a joint venture of Prelios and a RREEF fund.

Furthermore, Immofinanz acquired the residential real estate service business with approx. 300 employees from Prelios Deutschland GmbH. Luther also assisted this company in legal and tax aspects.

The transaction was not the first where Luther advised Immofinanz Group; for example in 2013 Luther assisted in legal and tax aspects of the acquisition of two residential portfolios in Lüneburg and Syke and the team in Berlin supported BUWOG inter alia in the acquisition of 2,000 residential units in Berlin.
