Radisson Blu, with a height of 108 m, is the second highest inhabited building in Hamburg and is only surpassed by the Elbphilharmonie (the new Elbe Philharmonic Hall). The purchase of the impressive building shows the confidence of Wenaasgruppen in Hamburg's international touristic appeal triggered by the Elbphilharmonie and the Congress Center Hamburg (CCH).
