## Luther Supports the City of Hilden in the Partial Sale of the Municipal Utility

September 23, 2008 – The city of Hilden has sold 49.9 per cent of its municipal utility for 51.8 million Euros to the Stadtwerke Düsseldorf AG. The city has been advised on the tender procedure by Luther Rechtsanwaltsgesellschaft.

The city of Hilden negotiated with three interested parties most recently, before the Stadtwerke Düsseldorf AG finally gained the tender. In addition to the purchase price the city of Hilden and the Stadtwerke Hilden GmbH will profit from further benefits in the amount of 1.73 million Euros. The total transaction volume amounts to 53.53 million Euros. The tender procedure has shown a distinctive pattern as it followed the body of regulations of EU public procurement law regarding public procurement procedures.
