Hannover, 18 June 2009 – In a structured bidding process, the Town of Einbeck has sold its shares in the municipal company Sertürner-Krankenhaus Einbeck GmbH to GeHoMa – Gesellschaft für Hospital Management mbH, a private hospital operator. The Town of Einbeck was advised by Luther Rechtsanwaltsgesellschaft mbH.
