Luther advises the first PPP project in Switzerland

Hamburg/Dusseldorf, 11 December 2009 - The Swiss-German Zeughaus PPP AG has been awarded the contract for the construction of the new city centre "Neumatt" in Burgdorf in the Swiss canton of Bern. Luther Rechtsanwaltsgesellschaft mbH advised the canton from the initial structuring of the procurement process up to and including the signing of the contract.

Within the scope of a public private partnership model, the new city centre "Neumatt" will be built on the former Zeughaus site in Burgdorf. The planning, building, financing as well as the running of the city centre, which will have a regional prison and an operations centre, over the next 25 years are part of the agreement, which was executed at the end of November between Zeughaus PPP AG and the canton's public authorities. The application for the building permit was made immediately on 1 December 2009. The canton remains the owner of the land and the buildings. Zeughaus PPP AG will receive an annual fee for its services. The Grand Council (*Grosser Rat*) of the canton of Bern has approved 18.15m Swiss francs per annum for the project. This is the first and largest PPP project of its kind and will be financed within the scope of project financing.
