New power on Saxony's energy market

20 September 2010 - The gas company Erdgas Südsachsen GmbH and the energy provider Stadtwerke Chemnitz AG have merged, retroactively from 1 January 2010, to become "eins energie in sachsen GmbH & Co. KG". The company's registered office is in Chemnitz. Co-owners of the company - via affiliated companies - are the City of Chemnitz and the gas supply association Zweckverband Gasversorgung in South Saxony with shares of 25.5% each, Thüga Aktiengesellschaft with 39.85% and the energy services provider envia Mitteldeutsche Energie AG (enviaM) with 9.15%.

The new company has approximately 1,100 employees and a balance sheet total of approximately EUR 900m. As a result of the merger, a fourth power has now entered the energy market in Saxony, which mainly offers electricity and gas, above all to the South Saxony region. "eins energie sachsen" is the sixth biggest investment in Thüga's portfolio.

The shareholders are expecting sustainable synergy effects and an improvement on performance from the merger. In addition, the merger means the cooperation between the City of Chemnitz and the Zweckverband, which comprises 125 municipal members, will be intensified, since both bodies were previously each sole majority shareholders of Stadtwerke Chemnitz AG and Erdgas Südsachsen GmbH, respectively. The merger had been under discussion for years and was one of the largest corporate transactions to take place in East Germany in 2010.

Background:

The roles in the Thüga Group are clearly defined: the partners do the active work on the market with their local and regional trademarks. Thüga deals with the network functions: acquiring new partners, coordinating and presenting projects and managing the working relationships.
