### Luther advises on the acquisition of the Damp Group

Dusseldorf/Frankfurt – The north German Damp Group, one of the largest private hospital operators in Germany, has been sold. The buyer is the Helios Kliniken Group, which has subscribed for approx. 95% of the shares in the Damp Group. Luther Rechtsanwaltsgesellschaft mbH provided legal transactional advice to the seller. The parties have agreed not to disclose the sale price.

"The sale of the Damp Group was the largest transaction in the hospital sector in Germany this year," said Dr Markus Schackmann, lead Partner and head of Luther's M&A practice group. Providing M&A advice to the hospital sector is one of the law firm's specialist areas (see clients on page 2).

The Damp Group owns, amongst other things, 11 acute inpatient and rehabilitation hospitals with a total of 4,112 beds together with numerous medical care centres and nursing and residential care institutions. Its network spans from Schleswig-Holstein to Hamburg and from Hamburg to Mecklenburg-Western Pomerania. With approx. 6,000 employees, the Group is one of the largest employers in Northern Germany. In the financial year 2010 the Group's total turnover was estimated at around EUR 487 million with operating earnings of around EUR 21 million. The majority interest in the Damp Group's share capital is held by R&W Industriebeteiligungen GmbH.
