Luther's tax team advises Axa Private Equity

Luxembourg – The steel group ArcelorMittal has sold its shares of 23.48% in the Luxembourg energy provider Enovos International SA to the financial investor Axa Private Equity, a subsidiary of the French insurance group AXA.

Axa Private Equity instructed the international organisation Taxand to advise the transaction from a tax law perspective. Together with Arsene Taxand and Atoz Luxembourg, Luther Rechtsanwaltsgesellschaft also carried out the tax due diligence. Additional advisers were, amongst others, the financial consultancy firm Accuracy, BNP Paribas, Clifford Chance and Roland Berger.

Axa Private Equity explained the reason for purchasing the shares is Enovos' potential for growth: amongst other things, it supplies power lines and gas pipelines. In 2011, Enovos generated sales of EUR 2.49 billion (2010: EUR 1.53 billion). The principal shareholder is the State of Luxembourg. Additional shareholders are SNIC (a State-run investment company), the City of Luxembourg, the world's largest steel supplier ArcelorMittal as well as the German energy providers E.ON, RWE and the Belgium firm Electrabel.
