Luther advises Fortress Group on Sale of Dresden Papier GmbH

Dusseldorf – Fortress Security Papers AG agrees to sell Dresden Papier GmbH, a leading international manufacturer of non-woven wallpaper base paper. Luther Rechtsanwaltsgesellschaft mbH advised the Fortress group of companies on the transaction led by the Canadian lawfirm Sangra Moller LLP.

Fortress Security Papers AG, a subsidiary of Fortress Paper Ltd., a Canadian company listed on the Toronto Stock Exchange, entered into an agreement to sell all the shares of its wholly owned subsidiary, Dresden Papier GmbH. Buyer is Glatfelter Gernsbach GmbH & Co. KG – a subsidiary of the American P.H. Glatfelter Co., one of the world's largest manufacturers of specialty papers. The agreement was signed in the mid of March. The aggregate purchase price is EUR 160 Mio or USD 209 Mio, subject to working capital adjustment. The transaction is subject to certain customary conditions, including approvals from the German and Ukrainian antitrust authorities. Luther acted as German counsel on behalf of the Fortress Group, including the seller, on this transaction.
