Luther advises the City of Offenbach on the sale of Klinikum Offenbach
GmbH to Sana Kliniken AG

Frankfurt – Luther Rechtsanwaltsgesellschaft mbH advised the City of Offenbach on the sale of the city hospital to Sana Kliniken AG. SynCap Management GmbH advised the City on financial issues.

On 2 May 2013, the City Council of the City of Offenbach approved Sana Kliniken AG's offer to buy 90 percent of the shares in Klinikum Offenbach GmbH.

"The goals set by the City of Offenbach have been achieved with regard to the procedure that was announced throughout the EU", said Thomas Köhler, Lead Project Partner at Luther Rechtsanwaltsgesellschaft mbH. A complex sales process, which was always characterised by competing for the best concepts for the hospital, had previously set the course for the sustainability of the hospital. "In particular, we would like to emphasize the constructive working relationships with all those involved in the project, especially the representatives from the City and the hospital, and also the cooperation between the employee representatives, bidders and advisors", added the City of Offenbach's representative, Prof. Dr. Dr. Friedrich Grimminger.

The project is one of the largest hospital privatisations of the last few years and due to difficult framework conditions, according to experts, is at the same time the most challenging transaction that has ever been implemented in Germany in the hospital sector. Klinikum Offenbach GmbH (which as a so called "maximum provider", has the highest level of medical care and employs more than 2200 members of staff), barely escaped insolvency in November 2012.
