Introducing good practices working with Women's Cafés and Sunday Cafés

at Rose Garden Hotel, Yangon, Myanmar

5th July 2017 (8:30 am to 4:30 pm)

Background

The regional program Social and Labour Standards in the Textile and Garment Sector in Asia (SLSG), implemented by GIZ, which works on behalf of the German Federal Ministry for Economic Cooperation and Development (BMZ), aims at strengthening communication and cooperation among employers, employees and government institutions to support them in achieving greater compliance with labour and social standards of the textile and clothing industries in Bangladesh, Pakistan, Cambodia and Myanmar.

The conference forms part of a larger SLSG intervention on empowerment of female garment workers in Myanmar which was subcontracted to sequa, the lead agency implementing SMART Myanmar. sequa is a non-profit development organization promoting the development of the private sector and its business membership organizations as well as vocational qualification. sequa's shareholders are Germany's top business membership organizations (DIHK, ZDH, BDA, BDI) and GIZ.

SMART Myanmar is a 2.8 million EUR project funded under EU's SWITCH Asia with the aim to advance social and environmental improvements in Myanmar's garment industry. One work stream in the project foresees to empower women to know and claim their rights.

Overview Parallel Breakout sessions

Objectives and intended outcomes

Each break out session will shortly be introduced by the moderator regarding the objectives and topics, quickly getting an overview about the knowledge of the participants of the topic.

Then the design of each session will vary, some will use power point and Q & A sessions, other sessions will have a panel of speakers who will present their experiences.

A) Presentation of smart phone app Shwe Job to inform about labour laws and OHS

Although Myanmar has recently introduced new labour and occupational health and safety laws, worker knowledge on such legislation is weak. In keeping with SMART Myanmar's and GIZ efforts to educate and empower female garment workers, the app is focused on educating garment factory workers on their rights under Myanmar labour and workplace safety laws.

The goal of this session is to increase practical know-how on smart phone apps; on how to design such app, on its content, the user profiles and the success of it so far as well as presenting the way forward with a second game-app. Also, during this interactive session, participants will be invited to share their knowledge regarding digital solutions to empower women. Participants will thereafter have more knowledge on key issues when introducing apps and may consider to introducing such app in their countries.

B) Legal counselling and mediation service

The Sunday Cafés and the Women's Cafés offer legal counselling for work and family conflicts by visiting legal advisors. This consultation, which focuses in particular on mediation, is intended to lead to the early resolution of conflicts. Women are encouraged to act more independently and more confidently.

The objective of the session is to increase knowledge and awareness on such services, compare and discuss Myanmar and Bangladesh models, define do's and don'ts, strengths, weaknesses, opportunities and threats, and also to compare different approaches in the delivery of such services.

D) Impact assessment of the approach – the Bangladesh experience

More than 200,000 workers have been aware through Women's Cafés in Bangladesh, where they learn through trainings, games, posters and films about their work rights. 20,000 of them have been trained as leaders through the 19 Women's Cafés built with the support of GIZ. Each week around 200 workers, especially women, visit one of the Women's Cafés in Bangladesh. They have gained knowledge on the legal social standards and conducting negotiations with the factory management. Legal counselling is also part of the offer of Women's Cafés. The impact of the Cafés was assessed systematically and the results of the assessment will be presented. The objective of the session is to share these experiences, discuss them and jointly identify possible additional issues/solutions to achieve even wider impact.
